TERMS & CONDITIONS

1. These are the terms on which DatacenterDynamics agree to accept the booking for its training course. They represent the entire agreement between you and DatacenterDynamics and by signing the training booking form you accept these terms and agree that any terms and conditions that you may supply or have supplied to DatacenterDynamics will not apply.

2. Telephone bookings will be noted but will not be deemed to be binding on DatacenterDynamics, DatacenterDynamics may resell the place until we have confirmed receipt of the written booking form. Written confirmation can only be accepted by DatacenterDynamics in the form of a booking form, duly signed and returned within five (5) working days. DatacenterDynamics may, at its discretion, extend this period.

3. DatacenterDynamics will, on receipt of a completed and signed training booking form issue an invoice, which must be paid in full within 15 days from the issue date or before the course commencement date, whichever comes first. The attendee will not be admitted on the course unless the course fee has been paid by the commencement date.

4. Substitutions may be made at any time. Cancellations must be received more than 30 days before the date of the training and will be subject to an administration fee of \$500 in case of CDCD™ course and \$220 in case of 1 day courses. All cancellations must be made in writing. Cancellations made within a month before the training are subject to the full fee.
